- Civil strife in Somalia since 1991 has led to a massive exodus of refugees to neighbouring countries. UNHCR has registered over 60,000 refugees, mainly Somalis, in Yemen. Most of these are self-reliant, but around 14,000 are currently living in a camp. WFP has been providing food assistance to refugees in Yemen since 1992. There are no signs that conditions in Somalia will allow a large-scale repatriation in the near future. Yemen is a least developed country (LDC) with a per capita annual income of under US\$300; it is also a low-income, food-deficit country (LIFDC).
- 2. The specific objectives of the protracted refugee and recovery operation (PRRO), pending the achievement of a durable solution for the refugees, are to: a) ensure that the basic humanitarian food requirements are met for the nutrition of refugees (mainly Somalis) in camps and transit centres in Yemen; b) encourage the children of Somali refugees to attend school by providing meals in schools; c) contribute to meeting the food needs of the most vulnerable groups of Somali refugees in slum areas through food distributions in a mother and child health care centre and at school; d) increase the vocational training of women and men in the camp through food incentives; and e) support camp construction and maintenance activities through food for work.
- 3. WFP provides basic food and UNHCR–supplied supplementary food. UNHCR is responsible for food distribution within the camp, implementing distribution through a local NGO, Partner in Development. Beneficiaries in the camp communicate with WFP and UNHCR and its implementing partners through two committees: the Elders' Committee, and the Women's Committee, which supervises the food distribution. WFP and UNHCR undertake a census of the camp population every six months; 53 percent of the adult population are women. UNHCR's implementing partner manages the camp, providing shelter, water, sanitation and health facilities. This includes food distributions and income-generating activities. WFP has recently established a sub-office in Aden which monitors projects in southern Yemen, including this PRRO. The Government provides a camp site for the refugees. Currently, there is only one camp, located at Al Gaheen (Abyan Governorate); this is regarded as a temporary site and a new camp is being prepared at Al-Kharaz (Lahej Governorate).
- 4. WFP's gross requirements for the PRRO are 3,836 tons of food (386 tons of carry-over stocks plus 3,450 tons of new commitments), valued at US\$2 million; the annual cost to UNHCR is around US\$1.9 million.
