The internal conflict, which erupted in the North-East of Sri Lanka in 1983 and escalated in June 1990, resulting in large-scale displacement of the population, continues unabated, with no immediate end in sight. WFP has been providing relief food aid since February 1992 to the poorest and the worst-affected internally displaced persons (IDPs).

- 2. Under this project relief food aid will be provided to 50,000 displaced persons in 173 welfare centres located in three districts outside the conflict zone. The project beneficiaries are those who have lost their property and all means of livelihood, and have been forced to flee their homes to save their lives. They neither have the means to manage on their own nor any relations and friends to help them. Taking refuge in the government-run welfare centres has been the only option available to them.
- 3. The scarcity of land on the island is a major constraint for any long-term settlement of the IDPs. A very limited number have been settled on state lands and on lands donated by philanthropic organizations, and have moved out of the welfare centres. The majority of the IDPs who continue to live in the welfare centres have few employment opportunities and are primarily dependent on relief assistance. The only viable long-term solution for the IDPs remains their return to their places of origin after the end of the conflict.
- 4. The Government's Department of Social Services has started an initiative to train women beneficiaries in marketable skills. Women who have been trained are given credit, from the savings generated through the sale of the empty containers of food commodities, to start micro-enterprises of their own. The Government intends to encourage the participation of NGOs in this activity. The NGOs are currently assisting in managing preschools, holding mobile health clinics, and in providing clothing and materials for housing the IDPs.
- 5. WFP will supply 7,300 tons of rice, 913 of pulses and 365 of sugar. These commodities will be combined with 456 tons of coconut oil, provided by the Government, to issue per capita daily food rations of 400 grams of rice, 50 of pulses, 20 of sugar and 25 of coconut oil.
