# SUDAN OVERVIEW

## CONTEXT

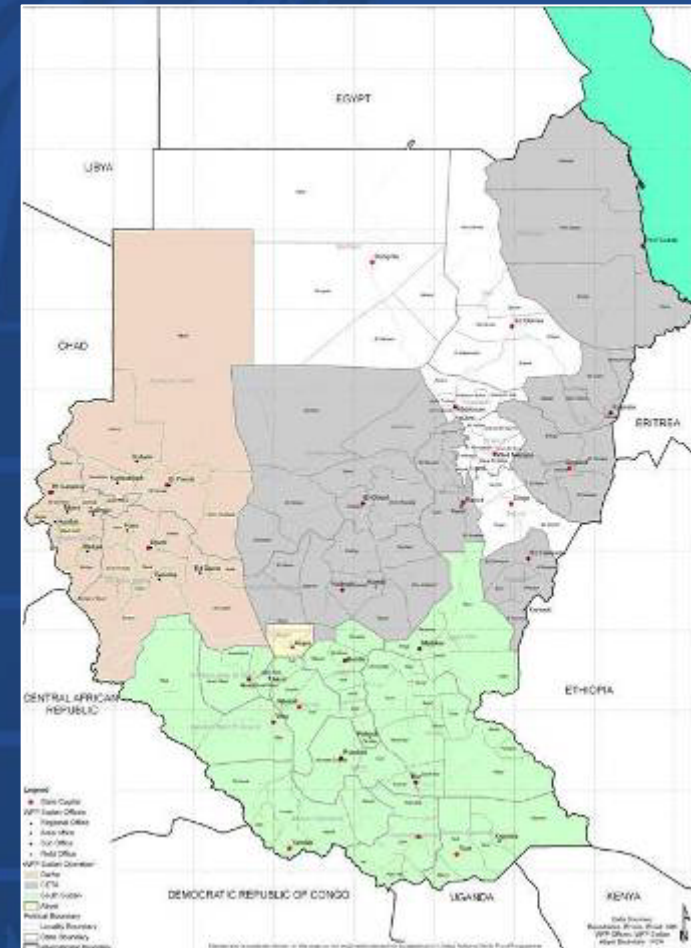
---

As critical milestones in the CPA approach, with elections scheduled for April 2010 and the historic referendum due March 2011, there is a real possibility that a humanitarian crisis may engulf Southern Sudan

Instability in the south could fuel tension and renewed conflict in the volatile Three Areas and the devastated East

Darfur peace negotiations have shown limited signs of progress

While government and rebel clashes in Darfur have reduced, tribal tension has increased and kidnapping of aid workers pose a new threat





# SOUTHERN SUDAN

## 2009 AT A GLANCE

---

Economic crisis and sharp decline in government oil revenues continue to present significant challenges for the Government in demonstrating peace dividends

Inter-tribal violence has killed more than 2,200 people and displaced 350,000 in 2009 including 85,000 people violently affected by the LRA

Food security has deteriorated substantially in large parts of Southern Sudan due to localized conflict and displacement, poor rains and high food prices

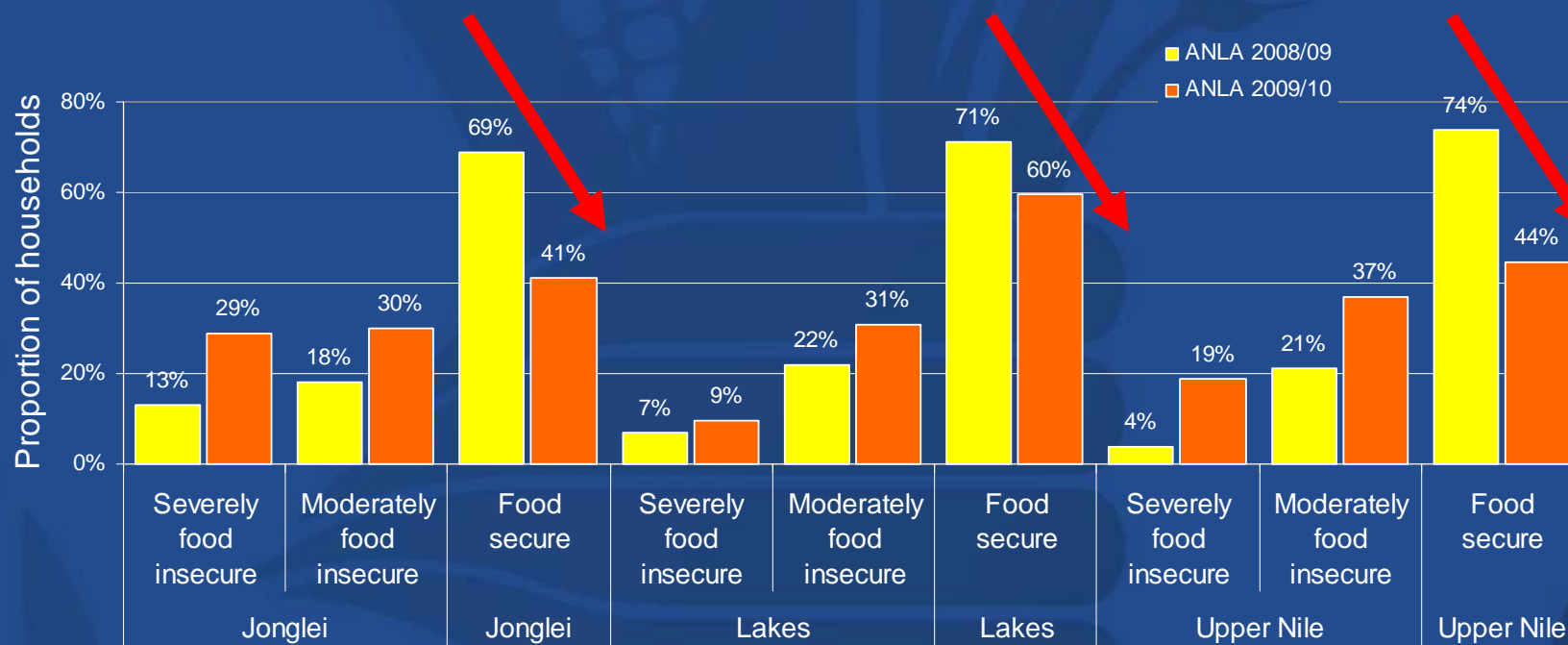
Emergency hunger gap response has already been initiated with an additional 22,000 mt for 300,000 people facing severe food insecurity in 6 of the most vulnerable states

---

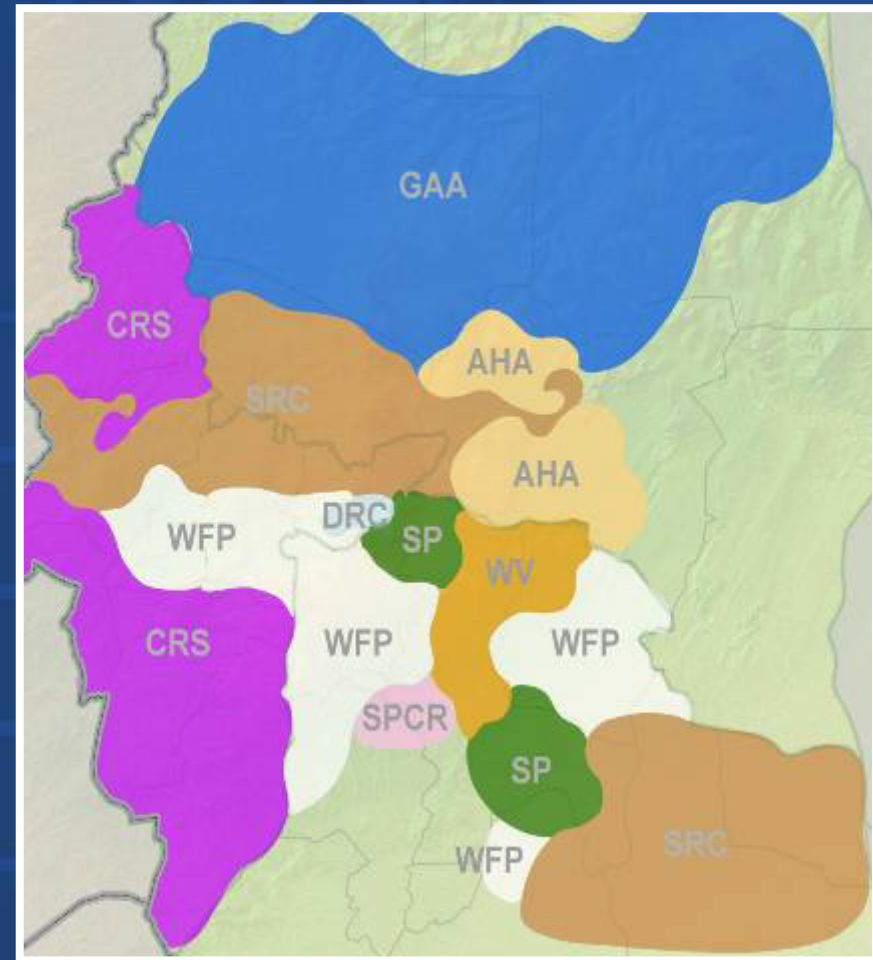
Safety net programmes to compliment a more nuanced GFD strategy – importance of Food Security Monitoring System (FSMS)

Outreach and engagement of Arab/Nomadic communities

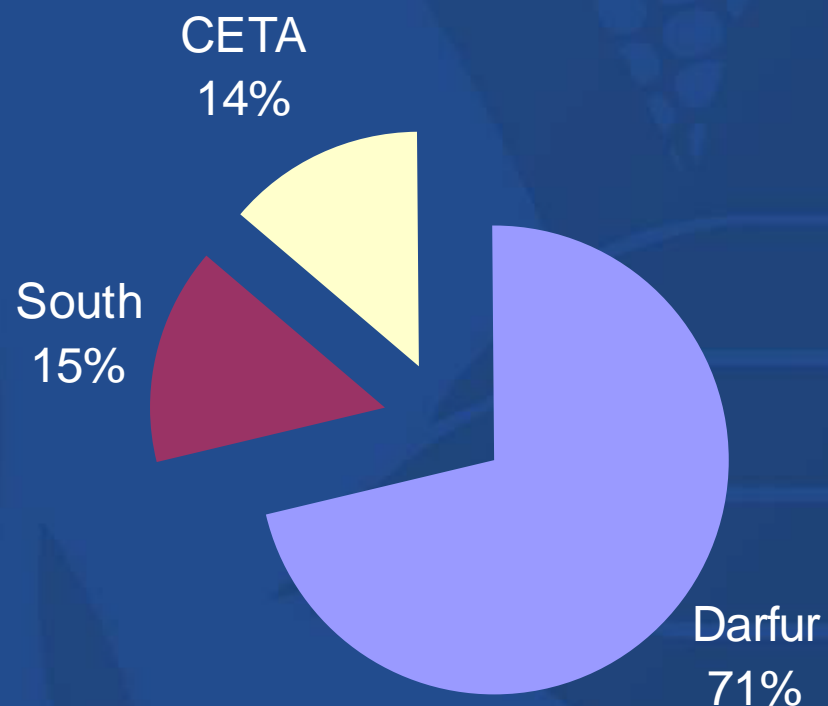
Filling the gap of the expelled NGOs –WFP still doing direct distribution for 45% of the affected caseload
