Management response to the recommendations from the summary report on the evaluation of the country strategic plan for Nepal (2019–2023)

Background

- 1. This document presents the management response to the recommendations in the summary report on the evaluation of the country strategic plan (CSP) for Nepal for 2019–2023.
- 2. The evaluation covered all the CSP activities implemented between January 2019 and June 2022. It assessed WFP's relevance, effectiveness and efficiency and the factors explaining WFP's performance.
- 3. Following a utilization-focused, consultative approach, the evaluation served accountability and learning purposes and informed the preparation of a new CSP for Nepal.
- 4. The evaluation made six recommendations, four of which are strategic and two operational.
- 5. The following response sets out whether WFP management agrees, partially agrees or disagrees with each of the evaluation recommendations and sub-recommendations and presents the planned (or completed) actions, responsibilities and timelines for implementing those recommendations.
