Mandate

- Article XIV Financial Regulations and Annex
- Appointed by the Executive Board (2022-2028)
- Audit Objectives
 - Opinion on the WFP financial statements
 - Efficiency of the financial procedures, the accounting system, the internal financial controls and, in general, the administration and management of WFP



Bundesrechnungshof

- Supreme Audit Institution of Germany
 - Audit of the federal funds of Germany
 - Reports to German Parliament
 - President Mr. Kay Scheller
 - UN Board of Auditors 2016-2022 (PKO, UNHCR, UNDP, ...)
 - Standing audit team
 - Focus on the field

- Specific examinations

2024 Audit - Audit Opinion

Unmodified audit opinion

"In my opinion, the accompanying financial statements present fairly, in all material respects, the financial position of WFP as at 31 December 2024 and its financial performance and its cash flows for the year then ended, in accordance with the International Public Sector Accounting Standards (IPSAS)."



2024 Audit - Recommendations

- 49 new audit recommendations to headquarters (Annual Report 2025)
- 105 new audit recommendations to Regional Bureaux* and Country Offices (Summary Field Report 2025)
- Follow-up of outstanding recommendations
- Only the External Auditor assesses his recommendations as
 - implemented
 - not implemented
 - under implementation
 - overtaken by events
