



# WFP's three lines model



First line roles:

Provision of products/services to clients; managing risk

Second line roles:

Expertise, support, monitoring and challenge on riskrelated matters

Third line roles: Independent and objective assurance and advice on all matters related to the achievement of objectives

Accountability, reporting

Delegation, direction, resources, oversight

Alignment, communication, coordination, collaboration

# WFP evaluation function oversight: Executive Board role in evaluation

#### **OVERSIGHT**

- Exercise oversight of evaluation function
- Guide management in policy implementation
- Consider Annual Evaluation Report & all centralized evaluation reports
- Consider management response & follow-up action reports

# NORMATIVE FRAMEWORK

- Approve appointment of **Director of Evaluation**
- Provide strategic guidance (Annual Consultation)
- Foster evaluation culture

#### **RESOURCING**

- Approve Office of Evaluation's budget
- Review trends in human & financial resources for evaluation

#### **PLANNING**

Review work plan & priorities within WFP's Management Plan

#### **USE**

- Consider **use of evaluation eviden**ce when approving new policies, strategies, programmes, Management Plans, etc.
- Use evidence generated by evaluation in decision-making

**POLICY** 

sets vision & strategic direction for WFP's new evaluation function



**STRATEGY** 

describes all the elements/workstre ams necessary for phased implementation



**CHARTER** 

sets new mandate, governance, authorities & institutional arrangements
