# Proposed change in evaluation policy (para 56) on Regional Evaluation Units (REU) budgeting and reporting lines



Each regional bureau will continue to maintain a regional evaluation unit headed by an experienced evaluation specialist reporting directly to the **Director of Evaluation (DoE) or designate**.



These posts are financed through **OEV's programme support and administrative budgets or alternative funding source** in order to ensure predictability, independence from programmes and adequate staffing.

## RD's evaluation-related accountabilities to continue

Overarching accountability (Management Accountability Framework): Regional directors ensure country offices effectively use evaluations to enhance learning, strengthen accountability, and enable evidence-based decision-making in the areas of their accountabilities

Regional engagement

- In partnership with other UN entities, supporting national evaluation capacity development at country and regional levels
- Supporting the commissioning and management of joint evaluations

# RD's evaluation-related accountabilities to be retained after removal/transfer

#### **Planning**

- Engaging in regular consultations with OEV and country offices to ensure complementarity among evaluations commissioned across the function;
- Ensuring that plans for evaluations are included in the design of regional strategies, interventions and other initiatives;
- Ensuring the preparation and annual update of regional evaluation plans. [Covered by the DoE]

#### Capacity development

- With OEV, providing technical advice to country offices managing evaluations; [Covered by the DoE]
- Contributing to the strengthening of evaluation capacity across the region;
- Facilitating evaluation capacity development initiatives in line with the WFP evaluation capacity development strategy.

#### Use

- Ensuring that CSP and new programmes, initiatives and strategies prepared in the region are based on evidence from evaluations; [Covered by all stakeholders]
- Ensuring that all reports on evaluations commissioned within the region are publicly available; [Covered by the DoE]
- Promoting the development of evidence products such as evidence summaries
- Facilitating the use of and learning from evaluation evidence within the region and among countries.

Reporting Line

- Keep expertise on the same time zone, with relevant language skills and regional knowledge, to respond to Country Office demands and to support use of evidence from all types of evaluations.
- Optimize human resource capacity across regions

   i.e. on language or areas of expertise.
- Utilize more efficiently financial resources across function given the demand-led approach to Decentralized Evaluations (DEs) and Impact Evaluations (IEs). Safeguards minimum capacity and business continuity.
- Reduces the risks of any perceived lack of independence.
