
ANNEX III-C: RESULTS AGAINST OUTPUTS, OUTCOMES AND CROSS-CUTTING PRIORITIES

1. This annex presents the results of output, outcome and cross-cutting priority indicators for operations active and monitored during the reporting year, using the methodology described in annex III-B.¹ It is intended to complement the summaries and narrative provided in part III of this annual performance report.
2. The following column definitions apply:
 - a) *No. of countries*: the number of country offices reporting against an indicator. This is the overall number for the indicator, even if – for cross-cutting indicators disaggregated by sex – the country may not have reported data disaggregated by sex for all of its measurements.
 - b) *No. of measurements*: the total number of measurements reported on against an indicator.² This is the overall number for the indicator, even if – for cross-cutting indicators disaggregated by sex – the country may not have reported data disaggregated by sex for all of its measurements.
 - c) *2025 planned or target*: the aggregated planned or corporate-level target value. For indicators measuring direct beneficiaries reached and transfers provided to improve their food security and nutrition status – most category A and B output indicators – the planned or target values are typically based on assessed needs, while the planned or target values for other indicators are based on the ability to implement the assessed needs with the forecasted resources.
 - d) *2025 actual*: the aggregated actual value achieved.
 - e) *Performance*: percentage of the target achieved.
 - f) *Improvement or stability rate*: percentage of measurements that improved or were stable compared with their baseline.
 - g) *Achievement rate*: percentage of measurements that met or exceeded their targets.
