The Board approved the annual performance report for 2025 (WFP/EB.A/2026/4-A), noting that it provided a comprehensive account of WFP's performance during the reporting period and of progress towards the objectives of the WFP strategic plan for 2022–2025 and the corporate results framework.

The Board commended WFP's employees for working under increasingly challenging conditions to assist more than 120 million people facing severe hunger. Those conditions included significant funding constraints, heightened insecurity, limitations on access, and attacks against humanitarian personnel, and while acknowledging that WFP appropriately prioritized life-saving assistance in emergency settings, the Board expressed concern that resource constraints had adversely affected the scale, duration and nutritional adequacy of the assistance provided.

In accordance with General Regulation VI.3, and pursuant to its decisions 2000/EB.A/2 and 2004/EB.A/11, resolution E/RES/2013/5 of the United Nations Economic and Social Council, and the decision adopted by the Council of the Food and Agriculture Organization of the United Nations at its 148th session in 2013, the Board requested that the annual performance report for 2025 be transmitted to the Economic and Social Council and the Council of the Food and Agriculture Organization, together with the present decision and the Board's decisions and recommendations for 2025.

The Board further acknowledged the synergetic nature of mandates of the Rome-based agencies in addressing global food security, and in the context of UN80, encouraged further actions that deliver impact, reduce duplication and overlap and enable cost-effective, efficient and accountable support to Member States.

The Board requested that WFP hold consultations with the International Fund for Agricultural Development (IFAD) and the Food and Agriculture Organization of the United Nations (FAO), with a view to present clear options to clarify ways to advance implementation of paragraph 58 of its strategic plan including to eliminate overlap and duplication. It further requested WFP, in coordination with IFAD and FAO, to jointly present these options at the requested Informal Joint Meeting of FAO Council, IFAD Executive Board, and WFP Executive Board in September 2026, as well as at the next session of the FAO Council in December 2026, in order to receive feedback from the Member States.
